Course Description

PH 365: Human Sexuality examines sociological, physiological, and psychological aspects of human sexuality in relation to family life, courtship, marriage, reproduction, education, and aging. It includes information on sexual assault, sexually transmitted infections (STIs), and HIV/AIDS.

Course Goals

The overall goals of this course include:

- 1. To introduce the core concepts of human sexuality across the globe and in society
- 2. To develop practical skills and exposure to communication, critical thinking, problem solving, self-reflection, and independent work ethic
- 3. To create a safe, active, and anti-oppressive learning environment where students can develop their skills and interests as adult learners

Course Objectives

Upon completion of this course, students will be able to:

- 1. Deconstruct the contemporary and historical views on human sexuality.
- 2. Critique methods that have been utilized in sexuality research.
- Classify appropriate terminology to describe male and female reproductive anatomy and physiology.
- 4. Organize and differentiate psychosexual development throughout the lifespan and related theoretical perspectives concerning sexual development.
- 5. Examine and reflect upon individual sexuality and relationships, including sexual identity, sexual values, gender roles, gender identity, sexuality through the lifespan, sexuality and disabilities, and sexuality and communication.
- 6. Critique contemporary societal concerns related to solitary and shared sex, same-gender orientation and behavior, same-sex marriage, and homo-/bi-phobia.
- 7. Outline the influence of culture, religion, politics, and the media on the spectrum of human sexual behaviors.
- 8. Distinguish sexual problems including sexual coercion, rape, and abuse; sexually transmissible infections; atypical sexual behaviors; and sexual dysfunction.

Course Activity Descriptions

All assignments are due 11:59 pm Sunday evening CT (discussion posts are the exception to this rule). Written assignments are to be double-spaced, one-inch margins, and in a standard font. References and citations should be used and should be in APA format. The wku.citation.guide is an excellent tool for assistance with APA if you are unfamiliar. This link is also included in Blackboard. Assignments should be uploaded as word documents or PDFs.

Class Readings

Students are responsible for textbook reading as well as reading/watching weekly material posted on Blackboard. Content may include power points, recorded lectures, videos, podcasts, or other medium. Content will be checked for accessibility; however, if there are issues accessing any content, please notify me immediately so I can fix it. Anything posted in course content is required unless otherwise noted by me.

Quizzes

There will be quizzes throughout the course of the semester. Students will access these via Blackboard. These quizzes are designed to ensure students are keeping up with and comprehending course materials. Students may use their notes and course material for the quizzes; however, answers must be in the student's own words. These are untimed and may only be completed once. *Objectives 1-8*

If a student misses a quiz, they will be allowed **one** makeup during the semester, otherwise, late quizzes will not be accepted.

Participation

Students will participate by completing discussion board posts in response to questions related to what we are learning. When there is a discussion board assignment, you will post three times. One will be a direct response to the question in the forum that must be submitted by **Wednesday night** of the week the discussions are due, and the other two will be additional posts commenting on your classmates' posts or comments that are due by **Sunday night** at the end of the week. *Objectives 1-8*

Self-Reflections

Periodically there will be self-reflection assignments. These self-reflections are meant to help you reflect on your own thoughts, opinions, and knowledge of human sexuality. There will be 10 topics you can choose from. During the semester, you will choose **five** of those ten topics to complete. These reflection assignments are meant to be written in essay form and do not require outside references. They do require proper formatting, critical thinking, introspection, and timeliness. *Objectives are dependent on which reflections are chosen.*

Critical Thinking Assignments

Students will be assigned two critical thinking assignments. These are informal written assignments meant for you to introspectively evaluate and analyze your attitudes, behaviors, and growth in relation to human sexuality. One will be due at the beginning of the semester and the other will be due towards the end of the semester. You will respond to prompts for these assignments. Additional instructions can be found on Blackboard. *Objectives 5-8*

Projects

Over the course of the semester, you will work on two different projects. One will be a media analysis where you will examine how the media portrays aspects of human sexuality. The second will be your choice between a field trip or an interview. There are several topic ideas for you to choose from for these assignments. You may also come up with your own topic proposal as long as it is approved by me. Detailed instructions can be found on Blackboard. *Objectives 5-8*

Extra Credit

There is one extra credit activity available to students for this course. Additional extra credit opportunities will be considered based on evaluation of the class progress according to my discretion. You cannot receive over 400 points in this class.

• If you meet with me at least once outside of class during the semester (Zoom or In Person; see my office hours above), you will be awarded 2 points toward your final grade.

We also honor and acknowledge the former residents of Jonesville. According to the Jonesville History Project, "Jonesville was a predominantly African American community in Bowling Green, Kentucky, which was demolished in the 1960s to make way for the expansion of the WKU campus. This incident echoed a pattern across the country where the power of eminent domain was utilized to seize property from minority communities for large public works projects under the guise of urban revitalization."

Attendance Policy (See University Policy)

It is the policy of Western Kentucky University that class attendance is an important part of a student's educational experience and is a requirement for success in courses. Registration into a course obligates the student to be regular and punctual in class attendance. The instructor should be notified by e-mail or telephone if a student is unable to attend before class begins. All students are given <u>FIVE free excused absences</u> that do not need an explanation. Beyond those five days, absences will need to be formally excused. Late/Makeup Work Policy

Due dates for every assignment are provided on the course schedule and posted on Blackboard. Unless otherwise stated, assignments are due on those days. Late work is discouraged as it can impact your learning and overall performance in the course. However, I recognize that sometimes "life happens." In these instances, please communicate with me **before the assignment deadline to propose an assignment extension**. Communication is key here.

If you do not communicate with me prior to the assignment deadline, then point deductions will occur for any assignment submitted after the deadline. There will be no penalty within the first 24 hours of the deadline to account for unforeseen circumstances. Following the first 24 hours, a deduction of 10% of your final grade per day will take place (weekends included). In case of documented emergencies or extenuating circumstances, exceptions may be considered. Please contact the instructor as soon as possible. I will evaluate these instances on a case-by-case basis.

Further, grading for late work will not be considered a priority for the instructor. Your grades may be delayed if your work is late.

Make-up Projects will only be allowed under circumstances that are recognized by the instructor or university such as death in the immediate family, excuse from a doctor, sickness, or emergencies.
