Course Description: This course provides an overview of long term care delivery in the United States, an introduction to the continuum of available long term care services with emphasis on institutional care delivery, and a discussion of the role of administration in present and future long term care delivery systems.

Course Structure and Content: This course is divided into four modules, each based on a specific student learning objective. Each week the student will have a reading assignment, a power point presentation to review, a written assignment, and a discussion board post.

Exams: There are 2 exams, each worth 50pts. Exams will contain a combination of true/false, multiple choice, and short answer questions. Exams must be proctored and taken at the DELO testing center on WKU's campus. An appointment must be made by the student to take the exam during the allotted time period.

Written Assignments: There are 7 written assignments, each worth 10pts. Assignments are evaluated in terms of both content and quality of writing. Written assignments are each to be approximately 1 page long, but may be up to 2 pages long if necessary to meet assignment objectives. Assignments are due before 11:59 pm on the Friday of the week they are due.

Discussion Board: There will be 11 discussion board items posted, each worth 10pts. Discussion board posts will remain open during the week that it is assigned. Students are expected to actively participate in the discussion board. Points will be assigned according to frequency of participation and quality of posting content. The items will be scored as follows: 0:Unacceptable/Not posted; 1-5:Needs improvement; 6-8: Good; 9-10: Excellent.

Meetings with instructor: Students are required to schedule 2 brief face to face meetings with the instructor, at a time of their and the instructor's convenience, during the course of the semester. Meetings must be at least 1 week apart from each other. Meetings do not need to be 1:1, students may schedule these meetings with other students. The purpose is to ask questions and briefly review course content as needed. Students will receive 10 pts. for each attended meeting. If this is a hardship, please contact the instructor during the first 4 weeks of class to make alternative arrangements.

Late assignments will not be accepted without approval of the instructor. Approval will only be granted in cases of emergencies or other extenuating circumstances. Any concerns regarding the grading of assignments need to be brought to the attention of the instructor within 1 week of the grade being posted.
