**Course Description:** This course will acquaint students with major conceptual literature on family stress and resilience. We will examine stress as experienced and perceived by children and their families. Factors that influence children's coping with stress are emphasized.

**Course Objectives and Outcomes**: Upon completion of this course, students will be able to:

- 1. Identify theories and models of stress as they apply to families and children
  - Students will be able to identify and apply theories and models of stress to families
- 2. Recognize and understand the secondary effects of exposure to stress
  - Students will be able to recognize and describe the secondary effects of exposure to stress.
- 3. Recognize and define social support systems
  - Students will be able to define and apply social support systems for those suffering from stress
- 4. Describe their roles in family stress as applied to their family
- 5. Recognize how families and family systems impact resilience
  - Students will be able to critique and describe how families and family systems impact resilience
- 6. Analyze and articulate coping strategies as related to families in stress

## **Grading Policy**

I grade on a percentage scale based on your total number of points compared to the total number of points available for the class as follows:

A = 100-90% B = 89-80% C = 79-70% D = 69-60% F = anything below 60%

- Students earn their grades. They are not given grades.
- If you have questions or concerns about an assignment, you should contact me immediately. Please keep track of your assignments and keep me on task with grading. Always make a back-up copy of your work!
- Your individual grades are available to you from the course grade book. If you have any questions about your grade please contact me.
- Your quizzes will be automatically graded and you should receive a score immediately.
- When determining final grades, I do not give grades; students *earn* their grades.
- I round grades at the .5% and higher. For example, if you have an 88.5%, that rounds to an 89%. That DOES NOT round to an A and that IS NOT one point away from an A. That is 1 percent from an A.

## 1. Class Attendance for Online Courses:

Class attendance is critical for success! Attendance policies not only apply to face-to-face classes, but they also apply to semester-based web classes.

Registration in a course obligates the student to attend regularly. In a semester-based online class, this
means signing into Blackboard for class review and/or participation at least twice each week. While On
Demand classes do not have an attendance policy, we recommend setting a calendar based on your goals
and adhering to that calendar, as there are time limits for course completion.

- Students enrolled online classes who, without previous arrangement with the instructor, fail to login to Blackboard during the first week of classes will be dropped from the course.

- Students wishing to change their schedule or add/drop a class, may do so during set time periods. Students

## 7. Incomplete:

A grade of "X" (incomplete) is given only <u>when a relatively small amount of work is not completed</u> because of illness or other reason satisfactory to the professor. A grade of "X" received by an undergraduate student will automatically become an "F" unless removed within twelve (12) weeks of the next full term (summer term excluded.) An incomplete must be removed within this twelve-week period regardless of whether the student is registered for additional work in the next term. A grade of "X" received by a graduate student, with the exception of thesis courses or similar projects, will automatically become an "F" unless removed within twelve (12) weeks of the next full term (summer term excluded). A student should work with the professor who assigned the incomplete on an independent basis in order to complete the necessary assignments. The grade of "X" will continue to appear as the initial grade on the student's transcript, along with the revised grade. A grade of incomplete is not used under any circumstances as a substitute for "F" or "W."

# 8. Withdrawal from the University

For various reasons it is occasionally necessary for a student to withdraw from the University. Prior to the midpoint of the semester, students may use TopNet to withdraw. After the midpoint of the semester, the student should report to the Office of the Registrar to initiate withdrawal procedures. Students leaving the institution without an official withdrawal will receive failing grades in all courses in which enrolled and endanger their future status in the institution. Students withdrawing after the midpoint of the semester, a bi-term or comparable period during the summer session must consult with their professors as to the withdrawal grade. The official date of the withdrawal is the date the withdrawal is processed on TopNet or the written notice is received in the Office of the Registrar. Students wishing to return to WKU at a later date must submit an application for readmission prior to the deadline for submitting applications.
