## **Course DESCRIPTION AND ObjectiveS:**

The purpose of this course is to identify basic legal principles that are applicable to sports and fitness management careers and learn how to effectively manage potential legal issues associated with injury, contracts and employment relations in intercollegiate athletics.

Upon successful completion of the course, students should be able to do the following:

- Identify and analyze legal issues that could arise due to injury or other accidents
- Identify and analyze the factors needed to create a safe working environment for your employees
- Identify the key factors needed for contracts and develop strategies for creating both employment and sales contracts
- Identify and analyze strategies for avoiding discrimination, harassment, or expression claims while still maintaining a safe and effective workplace
- Communicate solutions to legal problems through an accurate discussion of the appropriate legal principles
- Utilize legal principles to develop business strategies for the purpose of avoiding legal liability

#### **MEETING TIMES AND aVAILABILITY:**

This course is <u>not</u> a self-paced course, meaning that you cannot set it aside and do it all whenever you please. There are specific due dates for assignments and sections of the course that must be followed. I suggest that you set aside a specific time or times each week that will be devoted to working on this course. Because there is reading to go along with the lectures and assignments for this course, it will only help you if the reading is done before you complete any of the assignments.

Like a regular course, I will have set office hours where I will be online to answer any specific questions you may have for the class. I will also be online throughout the week to comment on discussions posts to help keep our discussions moving or re-focus the conversation. If you would

like to talk to me in person, we can set up an appointment to meet in my office.

This class will follow a basic framework where there are readings and/or lectures, followed by related discussions, and various assignments or projects to complete the unit. You will do well in this class if you follow along with the sections, do your reading, and share your observations before completing your assignments. Everything else, discussions and assignments, will have a specific due date to be followed to receive full credit for the assignment.

In addition to preparation, it is expected that you will demonstrate decorum and respect for yourself and other students. You can do this by being considerate of the thoughts of others and sharing your ideas in class discussions and group projects.

#### **Discussion Posts:**

A substantial portion of this class will be devoted to discussions on the message board. Since we don't have face-to-face class time, these message boards will be the best way to communicate with your fellow classmates, and to increase understanding of course materials and the subject of sport law.

#### **Case Study:**

Students will be required to present a legal case to the class to continue discussion and highlight how the related legal concerns work during a real life encounter. This will prepare and assist students in understanding how to apply the law to their future work experiences.

## **Writing Exercises:**

Throughout the semester, there will be assignments/writing exercises connected to class readings meant to further understanding of the material.

### **Quizzes:**

It is absolutely essential that class readings be read on time. Reading quizzes over that day's chapter will be given weekly to refresh your understanding of the subject material.

### **Examinations:**

There will be two exams, one at the midterm of the course and one final exam. Both examinations are constructed so that questions come from material presented in class and within the readings.
