**Course Title:** Physical Therapy Management and Administration I

<u>Course Description:</u> Introduction to basic principles of physical therapy-related leadership, administration, professionalism, and management. This includes an overview of business principles related to the various environments where physical therapists work. This course also serves to deliver foundational knowledge prior to the students' first clinical rotations and preparation for advanced principles in Physical Therapy Management and Administration II. Prerequisite: Open only to DPT students in good standing.

## **Course Objectives:**

## At the completion of the course content, the student will be able to:

- 1. Define fraud and abuse related to the utilization of and payment for physical therapy and other health care services. (7D3)
- 2. Communicate effectively with all stakeholders, including patients/clients, family members, caregivers, practitioners, interprofessional team members, consumers, payers, and policymakers. (7D7)
- 3. Demonstrate integrity in all interactions with patients/clients, health care providers, and other stakeholders. (7D7) (7D8)
- 4. Participate in professional and community organizations that provide opportunities for volunteerism, advocacy and leadership. (7D13)
- 5. Advocate for the profession and the healthcare needs of society through legislative and political processes. (**7D14**)
- 6. Define and discuss the areas of leadership, administration, professionalism, and management associated with physical therapist practice. (7D28)
- 7. Define various forms of organizational structure where physical therapist's practice.
  - a. Discuss and explain how organizational structure relates to physical therapist practice issues such as following medical orders and delegation of tasks to supportive personnel. (7D29)
- 8. Complete accurate documentation related to that follows guidelines and specific documentation formats required by state practice acts, the practice setting, and other regulatory agencies. (7D32)
- 9. Assess and document safety risks of patients and the healthcare provider and design and implement strategies to improve safety in the healthcare setting as an individual and as a

member of the interprofessional healthcare team. (7D37)

- 10. Participate in activities for ongoing assessment and improvement of quality services in various physical therapist practice settings. (**7D38**)
- 11. Discuss business management components marketing and public relations associated with physical therapist practice settings. (7D43)
- 12. Discuss foundational principles of accounting and finance, including developing and interpreting financial statements associated with physical therapist practice.
- 13. Discuss foundational principles of coding and billing associated with physical therapist practice: (7D43)
  - a. Demonstrate the ability to perform accurate coding and billing, as well as determining expected payment for services rendered.
  - b. Explain insurance reimbursement terminology and develop strategies for communicating and insuring appropriate documentation for third party payers.

#### **Course Structure and Learning Experience:**

The format for instruction is one that combines lecture, discussion, case studies, and group projects.

### **Evaluation Methods:**

#### • Attendance:

• Attendance and promptness to class will be monitored. Students are **considered tardy** if they do not arrive before the scheduled starting time (i.e. must sign-in no later than 2:59 for a 3:00 class and you must be <u>in your seat at your desk</u> ready to go by 3:00). As such, 1% of the total grade will be taken off per tardiness and 2% of the total grade will be taken off per **unexcused absence**. Refer to page 34 of the 2016 student manual.

#### • Assessment and Testing:

- **Exam**: There will be 2 exams via Blackboard. Exam 2 will not be cumulative. The exams are open note.
  - i. Exam 1 will open 7-19-2018 at 4 PM and close 7-22-2018 at 11:59 PM. You will have 1 hour to take the exam once you begin.
  - ii. Exam 2 will open 8-3-2018 at 12 PM and close 8-8-2018 at 11:59 PM. You will have 1 hour to take the exam once you begin.
- Each exam will consist of 25 multiple choice and/or true/false questions. If any student does not or cannot take the exam due to an emergency, then plans must be made at the discretion of the professor to complete all coursework within a specified time period. Each student must take all exams. If the exam is submitted late, there will be a 10% point reduction for each day it is late.

- **Group project proposal**: Students will be required to complete a 1 page summary (1-sided) group project proposal for establishing a business that will provide outpatient physical therapy services. The proposal is worth 50 points and will culminate in a group portfolio and presentation in DPT 762 during the 2019 Spring semester. A separate rubric and instructions for the 1 page summary will be provided in class.
- **Participation and Preparation**: Mandatory. Failure to participate including nonclinical use of your phone during class will result up to a loss of 2% off total points possible in the class per occurrence. The professor reserves the right to ask you to leave class if you or your phone becomes a disruption.
