Course Description: This course is designed to provide speech pathology/audiology students with opportunities to observe a minimum of 25 hours of evaluation/treatment for communication and/or swallowing disorders in children and adults.

Class Meeting Time: There is one **mandatory**, online class meeting for students enrolled in the web program to be oriented to policies and procedures for observation. Additional meetings may be scheduled if the instructor deems it appropriate. Students will be informed well in advance if this should occur. Otherwise, this class does not meet regularly. See information below for additional information.

First Meeting: August 24, 2016 from 4:30pm-5:30pm (CST) using Adobe Connect Online Classroom.

Learning Objectives:

The student will:

1. Learn observation skills to understand the skills necessary to function as a professional in communication sciences and disorders.
2. Be able to explain the perceived objectives observed in therapy and ways in which the objectives are targeted during therapy.
3. Complete the clinical record keeping form for clock hour documentation.
4. Identify types of observed disorders.
5. Identify types of intervention principles.
6. Chart client/clinician behaviors.
7. Complete 25 clock hours of observation of clinical services.

Required Text

No textbook is necessary for this course.

Completing Observations

Students will observe **ASHA certified** Speech Language Pathologists (SLP) providing evaluation and/or treatment of clients. Some hours may be under the supervision of ASHA

certified audiologist. Students will observe for a total of 25 clock hours across a variety of settings. Observation hours should vary in settings (medical, school, private practice, long term care, adult, pediatric) and may not all be completed at one type of site.

Settings in which students may observe would include: public school, early intervention, hospital, skilled nursing facility, outpatient clinic, rehabilitation hospital or anywhere that offers speech language pathology services provided by an ASHA certified SLP.

Students may not begin observations until after August 25th, 2016.

Observations using Master Clinician network: Students may complete no more than 12 observations hours by watching pre-recorded videos through a virtual service named Master Clinician. This option requires registration (usually in addition to a small fee), and you also must complete a short questionnaire following each video. Go to: www.masterclinician.org if you would like to explore using this option. Again, students choosing this option are responsible for any fees associated with this service. When registering students will need to use their full name, WKU email address and select WKU as his/her university/school. Master Clinician Network will report to the instructor the actual time observed, so be careful to document exactly the time observed in case the video was not watched in its entirety.

Documentation

For each session observed, an observation form must be completed and turned in to the instructor. The form is provided by the instructor. You must also turn in an hours log and summary sheets. Again, all documentation will be reviewed at the initial meeting and posted to Blackboard.

Course Evaluation

This course is graded either PASS or FAIL. This mean you must complete ALL requirements of the course successfully before receiving a grade or to pass the course.

Requirements for the Course

1. Attend the initial meeting through Adobe Connect and any other scheduled meetings with the instructor.
2. Complete training procedures for obtaining and documenting observations and clock hours earned.
3. Complete 25 clinical clock hours of observation over the course of the semester.
4. Follow all guidelines of conduct in the locations in which the student may observe. Attn: "Dress and Behavior Code" is to be followed at all sites where observing
5. Follow HIPAA guidelines and keep all identifying information regarding clients observed confidential.
6. Upon obtaining the 25 clock hours of clinical observation, correctly submit the following as an unstapled packet to the instructor via U. S. Mail no later than **November 30, 2016**:
 - a) Submit **ORIGINAL** Observation Worksheets for each session observed as a packet upon completion. Your hours from all of these worksheets added together will total a minimum of 25 hours as summarized on your Observation Summary Sheet.

- b) Submit the **ORIGINAL** Observation Summary Sheet, summarizing the 25 clock hours and dates of observation.
- c) ASHA guidelines indicate that I am unable to accept scanned copies of your documents. I must have the originals with your signature, so plan accordingly. You will need to get observations completed, forms completed, and everything in the mail in time for it to reach me by **November 30**. This allows us time to process and enter your hours by the time final grades are due.
- d) Use of white-out on forms is not acceptable. If a mistake is made draw one straight line through the error, initial beside the mistake in blue ink, and write in the correction.

*Notes: Any incidents violating privacy codes, dress codes, or failure to complete requirements, may jeopardize students' grades.

Course Policies

Communication

All class correspondence will be delivered to your WKU e-mail address or posted to Blackboard. Please check your e-mail and Blackboard regularly for class information, changes, and updates. E-mails to instructor will likely be answered within 24 hours of receipt, except if on a weekend (then allow at least 48 hours) or if the university is closed or on break.

Attendance and Participation

Attendance to online synchronous chats is required unless extenuating circumstances exist and previous arrangements have been made with instructor. Emergencies will be addressed on an individual basis and must be communicated to instructor as soon as possible. Attendance and class participation are essential to successful course completion.

Method of Instruction

Instruction is all online. One mandatory synchronous online class is on August 24, 2016, utilizing Adobe Connect Software. Additional meetings are a rare possibility. This course also uses Blackboard, reading assignments, and online learning activities.

Technology Management

Managing student technology is the sole responsibility of the student. The student is responsible for making sure that: (a) student word processing software is compatible with that used by the university; (b) student email software is working properly and that students know how to use it; (c) Internet service providers' equipment and software are installed and working properly in conjunction with student computers; (d) in the event that a student's computer stops working properly or becomes totally inoperable, the student needs another means by which she/he can successfully complete the course; and (e) any other student technology problem or issue gets successfully resolved, and this in part implies that if a student cannot resolve any personal technology problems, his or her only workable solution may be to drop the course.
