COURSE OBJECTIVES

This class is Pass/Fail. To earn a passing grade, students must complete all assignments and achieve required scores.

The purpose of this class is to assess and measure knowledge of basic ideas and concepts necessary for successful Finance graduates. All Finance majors should be able to demonstrate mastery of topics in principals of finance, investment theory, and advanced corporate finance. Financial management majors should also be able to demonstrate knowledge of topics from markets and institutions as well as international finance. Planning majors should demonstrate knowledge of topics from risk management, retirement planning, estate planning and tax planning for investments.

COURSE PREPARATION AND REQUIREMENTS

Finance graduates will be tested and evaluated on knowledge of theoretical concepts and analytical constructs in finance and general business topics. Review sheets are posted on Blackboard to help you in preparation for the assessment tests in Finance. There aren't any review materials for the College Exam. Specific questions over the material should be directed to the professor who regularly teaches the topic.

Testing & Evaluation

All exams must be taken using Respondus Monitor. You are given one opportunity to take each exam so prepare beforehand. There is a practice quiz posted on Blackboard for you to check the stability of your internet connection and to familiarize yourself with the Respondus browser. The password for the practice quiz is practice. There are 3 exams in this course:

- 1) College Exam (94 multiple choice questions from core courses in business no review materials available),
- 2) Long exam in Finance (65 multiple choice questions from FIN 332, 437 and 438 with approximately an equal number from each course review materials are posted on Blackboard), and
- 3) Short exam in either Business Finance or Personal Financial Planning (25 multiple choice questions). Review materials are posted on Blackboard. If you are a business finance major, you must take the business finance exam. If you are a personal financial planning major, you must take the planning exam. If you are a dual major, you may choose which exam you take.

Some test questions will be problem-oriented requiring the use of a financial calculator. Bring your calculator to all exams. A formula sheet is provided for the finance exams (not the college exam).

Students may not use language translators during exams. No electronic devices other than a calculator will be allowed during exams.

Long Exam in Finance – **February 25 or 26** – Dr. Snavely will post a spreadsheet on Blackboard for scheduling your day and time.

All students are required to take a *comprehensive 65 question* multiple-choice test. This test consists of material from FIN332, FIN437 and FIN438. A formula sheet will be provided. You must make at least 60% on this exam to pass this course. You have one chance so be prepared using study materials and asking for help from professors.

Short Exam in Business or Planning – April 7 **or 8 –** Dr. Snavely will post a spreadsheet on Blackboard for scheduling your day and time.

 Personal Financial Planning majors will take an additional test that includes material from FIN333, FIN350, FIN444 and FIN445.

Business Finance majors will take an additional test that includes material from FIN433 and FIN436. You must pass the short exam with a score of 60 or better this exam to pass this course. You have one chance so be prepared using study materials and asking for help from professors.

College Assessment Exam – January 28 or 29 – Dr. Snavely will post a spreadsheet on Blackboard for scheduling your day and time.

All students must take a general-knowledge exam with questions drawn from all areas of the core business curriculum. Bring your calculator. There aren't any review materials for this exam. This is an exam to see how much you recall from the business core courses.

Ethics Essay - Due by February 11 at midnight CT

You will be provided an article from the *Wall Street Journal*. Use the article to address the following: detail what the ethical dilemma or issue is, how it impacts stakeholders, and provide some potential resolutions. This is a business writing assignment. You will be graded on content, style, and argument. You will also be graded for grammar. Be sure to write using proper grammar, correct spelling, and proper sentence structure. This is not a texting assignment.

Grading

This class is Pass/Fail. That means that you <u>must</u> complete all assignments in this course, no matter what your average, in order to receive a passing grade. In addition, you must earn a score of at least 60% on the long exam and pass the short exam with at least 60%. Your final grade will be determined according to the following assignment schedule:

Personal Financial Planning majors (must complete all assignments to pass):

- Long Exam must answer at least 60% of questions correctly 60%
- Financial Planning (Short) Exam (must answer at least 60% of questions correctly) 25%
- College Exam 5%
- Ethics Essay 10%
 - = 100% of input to final average

Business Finance majors (must complete all assignments to pass):

- Long Exam must answer at least 60% of questions correctly 60%
- Financial Management (Short) Exam must answer at least 60% of questions correctly 25%
- College Exam 5%
- Ethics Essay 10%
 - = 100% of input to final average

A passing grade is an average of 60% or higher on the four above assignments/assessments.
