# **SYLLABUS TOPICS**

# **Course Requirements, Learning Objectives & Grading**

#### **Course Description:**

This is an introductory course on how natural earth processes can result in devastatingimpacts to the planet in terms of landscapes, climates, and the biosphere (with an emphasis on humanity). Students will understand:

- the physical processes behind Earth's natural hazards and disasters both on a geologic, historicandcurrent time scale.
- the methods used to predict such natural disasters
- risk factors associated with earth's natural disasters in terms of human impacts

#### **Colonnade Natural Science Requirement-new students**

For new students, this course fulfills the Colonnade Natural Science requirement (Explorations, non-lab).

#### **General Education Science Requirement – for returning students**

For returning students this course fulfills the General Education Category D Science (non-lab) requirement. This course is the equivalent of the old Geology 102 and Geography 100 courses. Student cannot earn credit for Geology 102 and Geography 100 and this course(Geology/ Geography 103) since they are the same course. Students taking Geol/Geog 103 from Fall 2014 onwards to satisfy the old General Education Science requirement will need to complete an ICAP exception formto substitute this course for Geology 102 or Geography 100 (see your advisor).

# Learning Objectives for Colonnade Program:

This course fulfills Colonnade Program's Systems category learning objectives. Students in this course will:

- 1. analyze how systems evolve.
- 2. compare the study of individual components to the analysis of entire systems.
- 3. evaluate how system-level thinking informs decision-making, public policy, and/or the sustainability of the system itself

*Course Learning and Content Objectives:* The learning and content objectives for GEOG 226 are designed to integratefully with the Colonnade Program. Upon successfully completing this course, students will:

- Understand geologic and atmospheric processes responsible for natural disasters and the geologic andatmospheric processes responsible for natural hazards, including earthquakes, volcanoes, tsunami, wildfire, flood, drought, tornadoes/hurricanes/cyclones, avalanche, landslides, asteroid impacts, climate change
- 2. Understand the geographic distribution of natural hazards and the frequency which these hazards become natural disasters
- 3. Know how society evaluates and confronts the dangers posed by these natural processes from apolitical, social, and ethical perspective
- 4. Know how technological innovations allow an increasing human population to monitor, predict, and warn society about natural hazards and impending disasters

#### Blackboard:

Blackboard is required for this course. All assignments, quizzes, grades ,and announcements will bemade available to the class through Blackboard at https://blackboard.wku.edu. Students will also utilize the site for submitting assignments.

#### **Technology Requirements:**

You must have access to a reliable Internet connection. It is suggested that Mozilla Firefox or Google Chrome are used as the main browser, as Blackboard often has trouble with Internet Explorer.

#### **Grading:**

Students grade performance will be based on participating and completion of assignments, quizzes, exams, and projects. A student earns the grade of 'A' by consistently producing excellent work **on time** and exemplary performance on exams and assignments. Adequately completing all assigned work, having successful exams, and contributing to class discussions on a semi-regular basis will result in a grade of 'B' for the course. If a student fails to participate regularly in class discussion or submits work/exams that is late, inconsistent with course standards, and/or incorrect will earn a grade of 'C' or below.

- Grade allocations are as follows: A: 90-100% B: 80-89% C: 79-70% D: 69-60% F: 59% or less FN: failed for non-attendance.
- *Grades of Incomplete (X)* will only be assigned if all but a small portion of coursework is left incomplete and theinability to complete the course is due to circumstances beyond the control of the student. An "X" will be given at the instructor's discretion.
