**Nursing 501 – Nursing Politics & Health Policy**

**Course Description:** Focuses on health care policy and policy analysis. Emphasizes the role of the advance practice nurse in health policy formation and political action.

**Course Objectives/Outcomes:** At the completion of this course, the student will be able to:

1. Describe the historical, social and economic influences on health policy.
2. Analyze the interface between health policy and political structure.
3. Evaluate the role of public opinion and health interest groups in the formulation of health policy.
4. Discuss the relationship of health policy and the political process in the areas of: healthcare finance, access to health care and health care reform.
5. Utilize a theoretical perspective for the analysis of policy issues and trends in nursing and health care.
6. Analyze roles played by advance practice roles to influence political process at all levels of policy makers, health care providers and consumers.

## **Assignments:**

### **1. Group discussions and participation**

Participation in group discussion and individual activities provides the opportunity to earn 50% points of the possible points for the course grade. Students are expected to participate in all online discussions of class topics by sharing appropriate resources and insights based upon class assignments, resources and work experiences. Class, though online, is not a spectator sport; you are expected to participate. Deadlines for posting in discussion boards will be strictly followed. Failure to follow the guidelines will result in a loss of participation points for that assignment. Alternate assignments cannot duplicate discussion and related activities. Information posted past the discussion board deadline does not contribute to the discussion or allow new insights for you or your group.

During the first two weeks of the semester, each student will have the opportunity to earn 10 points of the total possible points for the course. This assignment provides the student the opportunity to explore electronic websites and identify issues currently being discussed in the policy arena. The assignment will also require the student to critically think about the impact of the identified issues on health care or nursing practice and discuss these reflective thoughts with classmates on Discussion Board (DB). **Guidelines and a rubric for evaluating this assignment will be posted under the Assignment link on Blackboard.**

If faculty agrees to an alternative assignment due to an **extenuating circumstance**, only partial credit points (50%) will be awarded for satisfactory work, since the participation in discussion and content can not be duplicated through an individual assignment. **Work and/or failure to plan do not constitute extenuating circumstances.** A discussion board will be opened with each module (refer to course schedule in the syllabus section on Blackboard). You may have an individual assignment posted that you complete prior to visiting the discussion board. Review the guides or questions provided and other materials prior to posting. Discussion board postings that are inappropriate in content or depth usually result because the readings and assignments have not been completed prior to posting. Occasionally you will be instructed not to respond in the discussion board but to complete an assignment and submit to the instructor.

Dates for submission of assignments can be found on the course schedule. Please note that discussion boards end at 8am on the ending date. You will need to follow the date listed. No late submission will be graded. **A rubric to follow for evaluation of discussion board participation can be found in Course Modules and in your Group Discussion Board.**

## **2. Health Policy Analysis Paper**

This assignment provides the opportunity to earn 100 points and 25% of the final course grade. This paper allows your group to explore current and relevant health policy and political issues impacting advanced practice nurses and our patients, student, or employees and the ethical implications associated with the policy or issue. **. More detail about this assignment and the rubric for grading the Health Policy Analysis Paper will be posted under the Assignment link on Blackboard.**

## **5. Final Examination**

A final examination composed of 25 multiple choice items worth two points each will provide the opportunity to earn 25% of the course grade. The examination will cover content in the textbook readings and the other assignments in the course.
