1.	Objective: Outcome:	Introduce students to various substantive tort law topics Students will be able to identify and differentiate among intentional torts, negligence and strict liability; to identify the elements of each tort; to identify the defenses to each tort; and to identify the possible remedies to be sought in a court of law		
2.	Objective:	Familiarize students with the civil process involved in tort law litigation		
	Outcome:	Students will be able identify the stages of civil litigation and to provide litigation support throughout each phase		
3.	Objective:	Familiarize students with the rules of civil procedure that govern tort law litigation		
	Outcome:	Students will be able to identify and apply federal, state and local rules of procedure to tort litigation		
4.	Objective:	Familiarize students with ethical concerns arising in tort law litigation		
	Outcome:	Students will be able to identify the rules of professional conduct governing attorney and legal assistants in tort litigation; to identify violations of those rules and possible ramifications for those violations		
5.	Objective:	Develop student's ability to critically analyze federal and/or Kentucky appellate court decisions dealing with tort disputes		
	Outcome:	Students will be able to read court opinions written by various courts resolving tort disputes and to analyze the opinions critically from the perspective of both parties to the dispute.		

Attendance:

- •Ability to trace the legal history of each case study within the court system

- •Ability to analyze the court's reasoning and/or ruling based upon the case facts
- •Ability to synthesize and apply the legal concepts of tort law to factual scenarios in order to reach likely conclusions as to liability and damages
