COVID Information

Course Description

MATH 105 (1 credit hour) is designed to be corequisite support for students in Math 115C, Math 116C, or Math 123. Topics include functions, graphs and fundamental concepts of algebra.

The purpose of this course is to provide extra practice and opportunities for help in building up skills that support the MATH 116 material. This extra practice consists of video topics and short paper practice assignments.

You do not need to purchase any additional materials for this course. The work you do for MATH 105 is found in Blackboard. You will need to downloading and completing the notes and the homework practice assignments. You should place them in a separate section of the notebook for Math 116. These will be taken up weekly.
