## **Course Learning Objectives**

This course introduces basic accounting theories, concepts, and principles used to identify, gather, summarize, and report financial information. Emphasis will be on the components and preparation of the four primary financial statements.

# **Business Core Learning Objectives**

This course is one of the business core courses, which have the following objectives:

- Students will demonstrate communication skills in written and oral forms. Students will be evaluated on coherence and organization, delivery, grammar and syntax, and proper use of materials and mechanics in their communication samples.
- Students will demonstrate an awareness of ethical issues in business and society.
- Students will demonstrate the ability to solve problems through critical, reflective, and integrative thinking.
- Students will demonstrate an awareness of the global business environment.
- Students will demonstrate knowledge in each of the basic business disciplines including Accounting, Business Statistics and Quantitative Methods, Economics, Finance, Information Systems, Management (Organization and Management, Operations, Legal Environments), and Marketing.

#### **Prerequisite**

Completion of general education math requirement.
