Course Description:

Study of various perspectives of family life education, principles, and practices, including program planning, implementation, and evaluation. Field experiences required at student's expense.

This course is designed to provide an introduction into the development, implementation, and evaluation of family life education programs. Students will explore the history, principles, and current practices in family life education across the lifespan. Students will learn how to translate related research information into teaching activities appropriate for family life education programs.

Course Outcomes and Objectives: Students who successfully complete the course will be able to:

- Explain the value and purpose of family life education.
- > Trace the history and social importance of family life education.
- Name and explain the importance of the ten family life substance areas.
- Examine and evaluate family life education programs and websites for effectiveness. Observation of 6 hours related to your chosen program (follow COVID guidelines)
- Review relevant research in a particular topic area in family life education.
- > Develop a teaching unit including plans and activities for a specific family life education unit.
- ➤ Describe the means/methodologies for implementation, delivery, and/or evaluation of family life education programs.

Course Policies & Assignments:

- All assignments will be submitted via blackboard. Written work should be neat and grammatically correct. Points may be deducted for poor grammar, incorrect spelling and being submitted incorrectly.
