Course Description

MATH 105 (1 credit hour) is designed to be corequisite support for students in Math 115C, Math 116C, or Math 123. Topics include functions, graphs and fundamental concepts of algebra.

The purpose of this course is to provide extra practice and opportunities for help in building up skills that support the MATH 116 material. This extra practice consists of video topics and short paper practice assignments.

Corequisite

Corequisite: This course is required for students enrolled in MA 115C, MA 116C or MATH 123 if your:

- Math ACT score is below 20
- Math SAT score is below 520
- WKU Math Placement Exam (MPE) score is below 12

Since this course is a co-requisite course for the above-mentioned courses, you cannot withdraw from MATH 105 unless you also withdraw from your MA 115C, MA 116C, or MATH 123 course. Course Design Ove
