- 1. Describe and apply theories of nonprofit organizations and public policy to reflect an understanding of the importance of intersectoral relations in public governance (1.1)
- 2. Identify and describe the influence of nonprofit organizations on the public policy process (2.1, 2.2)
- 3. Analyze the impact of nonprofit organizations on alleviating public problems (3.1)
- 4. Describe and discuss how nonprofit organizations facilitate efficiency, effectiveness, technical and neutral competency, and participatory democracy in the provision of public goods and services (4.2)
- 5. Demonstrate the ability to effectively communicate policy information, both orally and in writing (5.2)

Class Participation

You are expected to read all the assigned materials, to complete assignments, and to participate in the class discussions. *Please note:* You earn class participation points through consistent, demonstrated engagement in the class, therefore, your presence in class meetings is *necessary*. Showing up, however, is not *sufficient* to earn class participation points. You must be prepared and speak up, i.e. *participate*, in discussion.

Each chapter in *Managing Nonprofit Organizations in a Policy World* ends with Questions for Review and an Assignment. You are *strongly* encouraged to answer the questions and complete the assignments; they will frequently be incorporated into the class discussions. We will also use Hypothesis software to facilitate electronic discussion/annotation of the supplemental readings. Your engagement with the readings via Hypothesis is considered part of your engagement/participation in class.

Case Study Analyses

Chapters 2 through 14 each include a case study. Discussion of these case studies will be incorporated into our class discussions. In addition, you will be required to submit written responses to the questions for two of the case studies – Exhibit 3.2 The Alliance for a Healthier Generation Partners with For-Profits to Make Public Policy (p.65-67) and Exhibit 7.3 Advocacy and Influence: National Rifle Association versus Gun Safety Organizations (p.160-164).

E-Portfolio

You are required to complete an e-portfolio that incorporates a minimum of six (6) required elements related to a not-for-profit organization of your choice. Drafts are assigned throughout the semester, so I recommend that you choose your program/organization as soon as possible. I will provide feedback but not a grade for the drafts. You must submit each draft by the due date in order to receive feedback so that you can complete revisions before submitting the final project. Please note that Artifact #6 will not be submitted as a draft, only as part of the final project.

Your e-portfolio should incorporate each of the following elements:

- 1. Nonprofit Organization Summary: Short paper (1 to 2 pages) that provides a description and general overview of the nonprofit organization including its stated mission, type of services provided, and policy positions/policy-related activities.
- 2. Analysis of the organizations recent Form 990: You will provide the link or submit the complete Form 990 document (as a .pdf file) as well as a 3- to 5-page paper in which you identify/assess the financial and policy-related information provided. Include discussion of the extent to which the Form 990 data provide a comprehensive view of the fiscal health and policy activity of your nonprofit. Feel free to incorporate a critique of the Form 990 requirements and/or weaknesses in how the nonprofit prepared the document.
- 3. Discussion/presentation related to a podcast episode: You should find a podcast episode related to one of the topics covered in the course. The artifact should include: the link to the podcast episode, 3-4 discussion questions related to the content of the episode, and a summary of the information related to the content to guide a discussion of the topic/questions identified. Artifact can be a short paper or PowerPoint presentation designed to facilitate a group discussion.
- 4. Identification/assessment of the social media, website, and other communication activities of the nonprofit: In a memo from you to me (no more than 2 pages, single-spaced), describe the social media presence which platforms, nature/frequency of content, level of engagement, etc. and other forms of communication by the nonprofit. Discuss the extent to which the organization is effective at communicating its mission and policy-related activities. What suggestions would you offer to improve the communication strategies of the organization?
- 5. Interview of a nonprofit professional: Each of you will draft 5 or more questions related to application of course topics, the day-to-day responsibilities of working for a nonprofit organization, ways in which the nonprofit is affected by and/or influences public policy, and/or other relevant topics. We will then pool the draft questions and you will decide as a group on a list of questions each of you will use for your interviews. Each of you will then write an article (2 to 3 pages) in which you present and discuss the results of your interview; use of a Q and A format in the article is appropriate; the article should be similar to what you would find in a magazine or trade publication.
- 6. Application of the Nonprofit-Policy Framework: Identify and briefly describe each of the four facets of the Nonprofit-Policy Framework. For each facet, identify and discuss an example related to your nonprofit. How does the Nonprofit-Policy Framework assist you in understanding the relationships between your nonprofit and public policy? Which of the four facets did you find the most relevant to understanding your nonprofit? Which was the least useful/applicable to understanding the policy-related activities of your nonprofit? Paper should be 4 to 6 pages in length.

You should use **appropriate and consistent citing of appropriate sources** throughout the e-portfolio. I encourage each of you to contact me for assistance with choosing an organization, conducting your research, and/or completing the artifacts. Resources for assistance in creating the e-portfolio are available on the course Blackboard site.

You will be required to make a presentation about your nonprofit to the class; use of PowerPoint or some other presentation platform is required. Presentations should be at least 8 minutes but no longer than 10 minutes. I will randomly assign presentation times; if you wish to negotiate with your classmates to exchange presentation times, you are free to do so, just let me know if any changes are to be made.

If you are not familiar with Blackboard, I encourage you to complete the Blackboard Student Training (instructions at https://www.wku.edu/online/orientation/using-bb.php).
