Course Description: Provides speech pathology/audiology students with opportunities to observe a minimum of 25 hours of assessment/treatment of communication disorders in children and adults. (Grading: Pass/Fail)

Optional Reference: *Master Clinician Network at* http://masterclinician.org. Students may complete guided observation hours by watching pre-recorded videos through a virtual service Master Clinician. This option requires registration, payment of a fee, and completion of a short questionnaire following each video. When registering students will need to use their full name, WKU email address and select WKU as his/her university /school. Master Clinician Network will report to the instructor the actual time observed, so be careful to document exactly the time observed

Course Evaluation

This course is graded either PASS or FAIL. This means you must complete ALL requirements of the course to successfully PASS the course

- Attendance: Attendance and participation are very important. You MUST attend ALL sessions to PASS. See Attendance and Participation policy.
- Complete 25 Observation Hours & supporting documentation: 1) observe ASHA
 certified speech language pathologists (SLP) or audiologists providing
 evaluation and/or treatment of clients; 2) Observe students in the WKU CD Clinic
 (if within driving distance); and/or 3) via the Master Clinician Network.
- Complete Individual Observation and Clinical Log documentation.

 <u>Reflection:</u> Participation in 11 Discussion Boards during the weeks between classes.

Instruction Details:

- 1. This course is graded as either PASS or FAIL. This means students must complete all requirements of the course to successfully to pass. To successfully pass this course the student will also:
- 2. Follow all guidelines of conduct in the locations where student may observe. Dress and Behavior Code is to be followed at all sites.
- 3. Follow HIPAA guidelines and keep all identifying information regarding observed clients confidential.
- 4. Forms to be uploaded onto Blackboard:
 - a. Individual Observations one each for individual watched due after each module, except when dealing with group therapy.
 - b. Clinical Logs .pdf forms due after each module used as accuracy checks
 - i. Assessment: 5 hours, including 2 adult & 2 child hours. This will include the CN videos viewed in class.
 - ii. Pediatric Treatment: 10 hours.
 - iii. Adult Treatment: 10 hours
 - c. Clinical Logs Excel form due by noon on 11/28. Feel free to turn these in early. Any corrections must be in by 4 p.m. on 12/2
 - d. NOTE: Use of whiteout on forms is not acceptable. If a mistake is made, draw one straight line through the error, initial beside the mistake, and write in the correction.
- 5. Observation setting types and client populations should be varied (medical (i.e. acute care hospital, outpatient clinic, rehabilitation hospital), public school, private practice, long term care (i.e. skilled nursing facility), pediatric (birth 17.11), adult (18+).
- 6. Students will observe American Speech-Language-Hearing Association (ASHA) certified speech-language pathologists providing evaluation and/or treatment of clients. This means that they have CCC-SLP after their name. Some hours may be under the supervision of an ASHA certified audiologist.
- 7. Students may complete all observation hours by watching videos and completing a short questionnaire after viewing each video at www.masterclinician.org. However, students are strongly encouraged to complete on-site observations, including the WKU CD Clinic (Covid regulations permitting.) Students choosing the non-WKU clinic option are responsible for any associated fees with the site. Students will register at the site using full name, WKU email address, and choose Western Kentucky University as the appropriate school. Master Clinician Network will report to the instructor the actual time observed. The student must

therefore record exactly the time observed if the video was not watched in its entirety.

- Learn observation skills to understand those necessary to function as a professional in communication disorders
- Explain the perceived objectives observed in therapy and ways in which the objectives are targeted during therapy
- Complete the clinical record keeping form for clock hour documentation
- Identify types of observed disorders
- Identify various types of intervention principles •

Chart client/clinician behaviors •

Complete 25 clock hours of observation of clinical services
