<u>Official Course Description</u>: This course will provide thorough training in the melodic, harmonic and rhythmic elements of music. Triads, intervals, keys, scales, cadences, notation, rhythmic reading, sight singing, melodic and harmonic dictation, and keyboard harmony will be covered in this course.

Homework:

All homework is due AT CLASS TIME every Tuesday. Late homework may be turned in for half credit up to seven days after the due date; after this point it will not be accepted and will be marked as a 0% in the grade book.
