

A. COURSE NECESSITIES

Marlowe, Joelyn D., *Evidence for Paralegals* (Aspen, 5th ed.) (any edition is okay, but note that chapter references in this syllabus are from the 5th edition)



B. LEARNING OBJECTIVES:

Upon completion of this course, students should be able to:

- 1. Identify and apply the Federal Rules of Evidence;
- 2. Understand the role that paralegals make in researching evidentiary issues;
- 3. Prepare pleadings and other legal documents according to the requirements of the local, state and federal rules;
- 4. Identify phases in civil trial process;
- 5. Understand the most common Hearsay rules and objections;
- 6. Identify Hearsay exceptions and anticipate the basis for such arguments;
- 7. Assist with pre-trial analysis of Evidence and recognize potential admissibility issues.
- 8. Demonstrate a basic understanding of Constitutional principles that effect admissibility in a trial.

IMPORTANT NOTE FOR PROFESSIONAL LEGAL STUDIES MAJORS: This course is required for all professional legal studies majors. For this course to count toward your degree, you must receive a final grade of "C" or above. For those majors receiving a final grade of "D" or "F," you must retake the course.

C. ATTENDANCE

Attendance is required. "Attendance" includes timely appearance in all synchronous class sessions. You cannot appropriately participate and be successful if you do not attend class regularly. Students must email the professor PRIOR TO CLASS to inform the professor in order to receive an excused absence. You will receive an "F" in this course if you miss more than four class meetings without an excused absence. Students who arrive more than fifteen minutes after class has started will be determined to be "absent."
