# **COURSE DESCRIPTION**

This course provides a general introduction to the criminal justice system, including the historical development of our system in the United States, featuring the fundamentals of the system and legal foundations, as well as the contemporary system of processing cases. We will examine different theoretical models for describing criminal behavior. The class will also cover ethical considerations for criminal justice professionals. We will devote attention to examining the structure and function of police organizations, the day-to-day responsibilities of police officers, some of the methods and challenges of police officers, and constitutional considerations for policing. As we move into the function of the courts, we will discuss the structure and function of the courts, identify members of the courtroom workgroup and their responsibilities, and end the section with sentences and punishments available to the court. Following that, we will cover corrections, including distinctions between jails and prisons, the world behind bars, and community corrections. Finally, we will take on specialty topics, such as juvenile justice, drug abuse, sex trafficking, terrorism, and immigration.

# **COURSE GOALS**

Upon successful completion of this course, you will be able to:

1. Describe the historical development of the American criminal justice system;

- 2. Discuss stages of the criminal justice process from arrest to sentencing to correctional options;
- 3. Explain the role of the police, including challenges, ethical considerations, limitations, and purpose;
- 4. Identify the major players in the courtroom and their roles, limitations, and authority;
- 5. Differentiate between probation and parole, jail and prison;
- 6. Identify special issues and populations within the criminal justice system, including juvenile offenders, female offenders, gangs, elderly offenders, and mentally ill offenders; and
- 7. Improve written communication skills through the submission of written assignments.

# HOW YOU WILL BE ASSESSED

#### *Quizzes (25% of final grade)*

Quizzes accompany each of the 12 units in this course, with one quiz per unit, adding up to a total of 12 quizzes. These quizzes are designed to test your understanding of the key concepts covered in each unit. The format of the quizzes will include multiple-choice, true/false, and short answer questions.

#### *Module Reflection Journal/Exercise (25% of final grade)*

A central part of this course is your active engagement with module readings. Unlike traditional journal entries, these module reflections can be completed through a range of mediums. Each reflection should focus on a key concept from the module readings. You will define this concept and apply it to a real-world scenario. You will complete a total of 4 reflections throughout the course, one for each module. While you have flexibility in when you complete each reflection, it must be submitted before the corresponding module's exam.

#### *Exams (50% of final grade)*

The course includes 4 exams - one for each module. These exams consist of various question types such as true/false, multiple-choice, matching, short answer, and essay questions, derived from lectures and assigned readings. Altogether, these exams contribute to 50% of your final course grade.
