### McGraw Hill Content Assignments: 50% of student's grade.

- 1. Online Exams: The online exams are each timed for 90 minutes. Once students open the exam in Connect, the clock starts. Students will have the opportunity to take each exam twice and Bb will record a student's highest score. The exam questions randomly chose 50 Multiple-choice questions from a large test bank for every single exam this means that no two exams will contain the same questions.
- 2. **Smart Book Assignments:** Assignment details are within McGraw-Hill Links. These may be completed an unlimited number of times before the due date.
- 3. **Boeing Case Studies:** Assignment details are within McGraw-Hill Links. These can only be completed one time before the due date and are open book.

**Packback Written Assignments**: 50% of student's grade. My goal in incorporating Packback is to enable students to productively engage with Artificial Intelligence with the aim of enhancing their curiosity, self-assurance, and written communication skills. Given that this online course operates asynchronously without the opportunity for live conversation, it is imperative that student's key assertions in every assignment demonstrate analytical depth, thoroughness, and precision.

- 1. Packback Discussion Boards: Assignment details are within the Packback Links. Please be professional and respectful in responses to two peers. For best Discussion Board grade outcomes please cite at minimum one reputable source in APA format (i.e., course text, Harvard Business Review, Google Scholar, WKU library resources).
- 2. **Individual Application Paper Development:** Students should initiate the development of their Week 9: Packback Deep Dive content in Week 5 and complete submissions by Week 9. Following this, students should integrate their submissions from the Week 9: Packback Deep Dive into the APA Paper Format starting in Week 10 as outlined. The Final Individual Application Paper Prompt and Rubric are in the Week 14 Folder for reference.

#### **BIG RED BACKPACK**

The Big Red Backpack program is the title of WKU's partnership with Barnes & Noble College for their First Day Complete initiative. Big Red Backpack is a course materials delivery program that ensures students have their required course materials on the first day of class and may reduce the costs of materials for many of their courses.
