COURSE DESCRIPTION

Expansion on previous medical-surgical concepts utilizing basic human needs, developmental theory, nursing process and evidence-based interventions to promote and maintain health for selected populations.

- 8. Demonstrate a spirit of inquiry and examines the evidence that underlies clinical nursing practice to enhance quality and safety in health care. (EOPSLO #8)

Students will be given prior notice for any required learning activities/workshops/testing/etc. that are scheduled outside class/clinical time. Attendance for these additional activities is mandatory to successfully meet the objectives of NUR 255.

Evaluation/Grading

The final grade for each student will be based on a percentage of total points obtained. Seventy percent (70%) of the course grade will be awarded from unit exams and a comprehensive final. Ten percent (10%) of the grade will be awarded from the student's conversion score of the HESI Med-Surg III Exam. Ten percent (10%) of the grade will be awarded from the student's conversion score of the HESI Exit Exam A. Ten percent (10%) will be awarded from the student's conversion score of the HESI Exit Exam B. Unit examinations will consist of various test question formats including but not limited to multiple-choice questions. The final exam will be comprehensive. Testing material may be taken from text reading assignments, class lectures, handout materials, study guides, case studies, instructional audio/video recordings, and assigned readings from sources other than course text.

Use the following formula to calculate student course grade:

Tests for this course shall be taken at the WKU South Campus Testing Center, an approved off-campus testing center, or via Proctor-U. All HESI Exams shall be taken at the WKU South Campus Testing Center or via Proctor-U. It is the student's responsibility to schedule each test using the directions sent to students via email by the Distance Learning Testing Center. Students must complete all exams between the hours of 6:00 AM and 6:00 PM CST on the assigned day.

A student may not take an examination other than the scheduled date without satisfactory justification. The faculty member responsible for the course will decide if the justification is satisfactory. The student who does not notify the faculty of an absence for an examination and/or who cannot provide satisfactory justification for the absence can still take a makeup examination, but the achieved score will be reduced by 10% of total points possible. At the discretion of the course instructor, any makeup exam may consist of different test items or essay questions. Students are responsible for notifying their instructor if they are unable to take a scheduled exam prior to the scheduled test time. Makeup exams will be given as soon as possible, preferably within one week of the date of the original exam.

In order to successfully complete the course a 77.0% minimum will be required. A student with an average of 76.9% or below will not be successful. Students must also achieve a satisfactory evaluation in NUR 257. If a student is unsuccessful in either NUR 255 or NUR 257, both courses must be successfully repeated before the student is allowed to progress in the program.

An opportunity to improve course grade will be available by completing additional assigned activities each week. Activities are assigned from HESI® CompassTM, a culturally diverse end of life discussion board, Spirit of Inquiry, and a COVID-19 Nursing Care activity. Student's progress in HESI® CompassTM will be tracked through the Slack Channel. Students will submit the Spirit of Inquiry Assignment through the discussion board on Blackboard. Student performance on assigned activities can improve the exam portion of the overall course grade. Students who earn less than 119 credits will not pass the course and will receive a grade of "D", regardless of student performance on exam grades. In order to add activity credits, the student MUST have a course grade of at least 77.0%.

Additional points will be added as follows:

- 119 135 credits will add **ONE** points to total examination points
- 136 152 credits will add **THREE** points to total examination points
- 153 170 credits will add **FIVE** points to total examination points

Test Review

Test feedback via ExamSoft will be made available to students within one week after an exam. Individual student appointments can be made for further test review with faculty and must be completed prior to the next test in that course. **No written notes or audio recording may be made during test review.** Final exams cannot be reviewed, and students will not receive feedback for the final exam. Appointments for test review with faculty members can be made using email.

Any appeals for an alternate response to be counted as correct must be negotiated with the course faculty. Students have one week following the grade to challenge the test or assignment grade. Challenges must be made in writing and based on material the student can reference in their textbook. HESI Compass

HESI Compass is integrated into this course and comprises part of the activity points for the course. Successful completion of HESI Compass components as directed is required to pass NUR 255. HESI® CompassTM is delivered as an online course in Evolve. HESI Compass builds student NCLEX readiness through individualized student learning pathways. In a virtual environment, content is delivered by review modules, secure reliable HESI Assessment readiness indicators, and an experienced virtual nurse educator coach. HESI Compass prepares students for HESI Exit exams and the NCLEX licensure exam.

A synchronous, multi-day live NCLEX-RN review course via Zoom is required of each student during the last semester of the nursing program. Should a student be absent from any portion of the mandatory review regardless of reason, completion of an alternate assignment will be required. The alternate assignment will require an extensive amount of time and student effort to complete. If the alternate assignment is not completed prior to semester end, the student will receive the grade of incomplete for the course which could result in delay of graduation date.

NCLEX-RN and Licensing Information

NCLEX-RN and licensing information for KY and TN is located on your Blackboard site. You may take the NCLEX at a Pearson Professional Center in any state, but if you plan to be licensed in a state other than Kentucky or Tennessee, contact that state Board of Nursing before mid-term. After official notice from the Office of the Registrar to the LPN to ASN Program that your Associate of Science in Nursing degree has been awarded, the ASN Program will verify your degree with the KBN. The Office of the Registrar will not release your official transcript until all financial obligations to the University have been satisfied.

The Board of Nursing shall have power to deny any license to practice nursing upon proof that

the person has been convicted of a misdemeanor or felony. If you have a prior criminal history or conviction record, contact the course coordinator and see LPN to ASN Student Handbook for Kentucky Board of Nursing regulation 201, KAR 20:370 Applications for Licensure and Registration.

Students wishing to appeal a test or assignment or other grade in this course must follow the following process.

Course Grade appeals must follow the university academic complaint process outlined in the WKU Student Handbook at https://www.wku.edu/handbook/academic-complaint.php. Grade appeals (students seeking a change in grade) **must be based on an error in grading** (the student did not get the same points for the same response as everyone else in the class). If there is no error in grading and there is no math error in calculating the student's grade, then there is no basis for a grade appeal. Grades will not be changed just because a student is short of points to pass the course. Additional points for test or other assignments will not be considered after the student has failed the course, unless the test falls within the one-week challenge period. Any test item challenges must be conducted in the week following the exam and must be resolved with the faculty member at that time, based on information from the course materials such as the textbook. The faculty member is considered the expert and the faculty members' option of the correct answer will be the final answer.
